Picklists

The State-Wide Equipment Program (SWEP) generates and maintains picklists for the use of SWEP registered Practitioners. All picklists are generated with the input and rationalisation of the SWEP Clinical Advisory Panel who are groups of clinicians with expertise in prescription of equipment and at least ten years' experience in their area. There is a Clinical Advisory Panel for Children and one for Adults. Within each panel, there are sub-specialties for each equipment category.

All items on this quotable pick list require quotes and specifications to accompany the application. Reissue items do not require a quote unless there are modifications required to that item.

SWEP Practitioners have access to a pool of reissue equipment held at Chemtronics in Thomastown. Reissue equipment consists of items of Assistive Technology that have been refurbished and checked over to ensure they are in good condition for use. Please note we do not reissue low cost items.

Consumer applications where a reissue item has been selected do not go on our waitlist for funding. These applications are funded upon processing of a complete application. Reissue Items have their own Picklist Code in the category list, on the application you choose reissue item, then from the Picklist List enter the reissue picklist and it will then ask you to enter the Asset number and reservation ID from Chemtronics. Please note that some items may require co-contribution's due to SWEP subsidy funding levels. Items such as pressure care cushions are subject to subsidy timeframe limitations and a consumer who has previously accessed an item may have an altered co-contribution requirement.
