

SWEP PERFORMANCE REPORT CARD

NOVEMBER 2019



The State-wide Equipment Program (SWEP) aims to provide eligible consumers with subsidised assistive technology (AT) to enhance independence in their home, facilitate community participation & support families & carer's in their role.

There are many subprograms for different types of AT items including: Aids & Equipment Program (A&EP Adults and Children); Repairs; Continence Aids (CA); Domiciliary Oxygen (DOP); Supported Accommodation Equipment Assistance Scheme (SAEAS); Vehicle Modification Subsidy Scheme (VMSS); Reissue; Lymphoedema Compression Garments Program (LCGP) and Laryngectomy Consumables Program (LCP).

Below is a basic breakdown of the achievements each program has made in the month of November 2019.

A&EP ADULT

This month we have:

- Received 962 applications for adults requiring assistance.
- Assisted 905 adults with funding towards their AT items.
- Assisted with the purchase of 1,502 individual AT items.

A&EP CHILD

This month we have:

- Received 21 applications for children requiring assistance.
- Assisted 10 children with funding towards their AT items.
- Assisted with the purchase of 19 individual AT items.

SAEAS

This month we have:

- Received 6 applications for consumers requiring assistance.
- Assisted 3 consumers with funding towards their AT items.
- Assisted with the purchase of 8 individual AT items.

DOP

This month we have:

- Received 140 applications for consumers requiring assistance.
- Assisted 3,396 consumers receiving oxygen.

CONTINENCE AIDS

This month we have:

- Received 296 applications for consumers requiring assistance.
- Assisted 498 consumers with funding towards their products.
- Assisted with the purchase of 1,149 individual products.

VMSS

This month we have:

- Received 2 applications for consumers requiring assistance.
- Nil modifications were funded this month

SWEP LCGP

This month we have:

- Received 142 applications for consumers requiring assistance.
- Assisted 117 consumers with funding towards their garments.
- Assisted with the purchase of 244 individual garments.

LARYNGECTOMY

This month we have:

- Received 29 applications for consumers requiring assistance.
- Assisted 27 consumers receiving laryngectomy consumables.
- The most common consumable purchase this month is Heat Moisture Exchanges.

REPAIRS

Our contracted Supplier for Repairs (Chemtronics) have attended to repairs of 715 AT items.

The most common items repaired this month were Manual Wheelchairs and Power Wheelchairs.

REISSUE

This month we have reissued 120 refurbished AT items to consumers requiring assistance.

We currently have 1,101 refurbished AT items in our warehouse and have collected 269 AT items that are no longer required and are pending refurbishment.
